STATE WATER CONTROL BOARD ENFORCEMENT ACTION - ORDER BY CONSENT ISSUED TO COUNTY OF HENRICO FOR HENRICO COUNTY WATER RECLAMATION FACILITY VPDES Permit No. VA0063690

SECTION A: Purpose

This is a Consent Order issued under the authority of Va. Code § 62.1-44.15, between the State Water Control Board and the County of Henrico, Virginia regarding the Henrico County Water Reclamation Facility, for the purpose of resolving certain violations of the State Water Control Law and the applicable permit and regulation.

SECTION B: Definitions

Unless the context clearly indicates otherwise, the following words and terms have the meaning assigned to them below:

- 1. "305(b) report" means the report required by Section 305(b) of the Clean Water Act (33 United States Code § 1315(b)), and Va. Code § 62.1-44.19:5 for providing Congress and the public an accurate and comprehensive assessment of the quality of State surface waters.
- 2. "Board" means the State Water Control Board, a permanent citizens' board of the Commonwealth of Virginia, as described in Va. Code §§ 10.1-1184 and 62.1-44.7.
- 3. "cfu" means colony forming units.
- 4. "Collection system" or "sewage collection system" means the wastewater collection system owned by Henrico County and consisting of pipelines or conduits, pumping stations and force mains, and all other construction, devices and appliances appurtenant thereto, used for the collection and conveyance of waste streams to the Henrico County Water Reclamation Facility or point of ultimate disposal.

- 5. "Department" or "DEQ" means the Department of Environmental Quality, an agency of the Commonwealth of Virginia, as described in Va. Code § 10.1-1183.
- 6. "Director" means the Director of the Department of Environmental Quality, as described in Va. Code § 10.1-1185.
- 7. "Discharge" means discharge of a pollutant. 9 VAC 25-31-10
- 8. "Discharge of a pollutant" when used with reference to the requirements of the VPDES permit program means:
 - (a) Any addition of any pollutant or combination of pollutants to surface waters from any point source; or
 - (b) Any addition of any pollutant or combination of pollutants to the waters of the contiguous zone or the ocean from any point source other than a vessel or other floating craft which is being used as a means of transportation.
- 9. "DMR" means Discharge Monitoring Report.
- 10. "Effluent" means wastewater treated or untreated that flows out of a treatment plant, sewer, or industrial outfall.
- 11. "Facility" or "Plant" means the Henrico County Water Reclamation Facility located at 9101 WRVA Road in Henrico County, Virginia, which treats and discharges treated sewage and other municipal wastes, for the residents and businesses of Henrico County.
- 12. "Henrico" means the County of Henrico, a political subdivision of the Commonwealth of Virginia. Henrico is a "person" within the meaning of Va. Code § 62.1-44.3.
- 13. "Notice of Violation" or "NOV" means a type of Notice of Alleged Violation under Va. Code § 62.1-44.15.
- 14. "Order" means this document, also known as a "Consent Order" or "Order by Consent," a type of Special Order under the State Water Control Law.
- 15. "Permit" means VPDES Permit No. VA0063690, which was issued under the State Water Control Law and the Regulation to Henrico on June 1, 2017, and which expires on May 31, 2022.
- 16. "Pollutant" means dredged spoil, solid waste, incinerator residue, filter backwash, sewage, garbage, sewage sludge, munitions, chemical wastes, biological materials, radioactive materials (except those regulated under the Atomic Energy Act of 1954, as amended (42 USC § 2011 *et seq.*)), heat, wrecked or discarded equipment, rock, sand, cellar dirt and industrial, municipal, and agricultural waste discharged into water... 9 VAC 25-31-10.
- 17. "Pollution" means such alteration of the physical, chemical, or biological properties of any state waters as will or is likely to create a nuisance or render such waters (a) harmful or detrimental or injurious to the public health, safety, or welfare or to the health of animals, fish, or aquatic life;

(b) unsuitable with reasonable treatment for use as present or possible future sources of public water supply; or (c) unsuitable for recreational, commercial, industrial, agricultural, or other reasonable uses, provided that (i) an alteration of the physical, chemical, or biological property of state waters or a discharge or deposit of sewage, industrial wastes or other wastes to state waters by any owner which by itself is not sufficient to cause pollution but which, in combination with such alteration of or discharge or deposit to state waters by other owners, is sufficient to cause pollution; (ii) the discharge of untreated sewage by any owner into state waters; and (iii) contributing to the contravention of standards of water quality duly established by the Board, are "pollution." Va. Code § 62.1-44.3.

- 18. "PRO" means the Piedmont Regional Office of DEQ, located in Glen Allen, Virginia.
- 19. "Regulation" means the VPDES Permit Regulation, 9 VAC 25-31-10 et seq.
- 20. "SSO" or "sanitary sewer overflow" means the discharge of wastewater (including infiltration and inflow) from a sewage collection system.
- 21. "State Water Control Law" means Chapter 3.1 (§ 62.1-44.2 et seq.) of Title 62.1 of the Va. Code.
- 22. "State waters" means all water, on the surface and under the ground, wholly or partially within or bordering the Commonwealth or within its jurisdiction, including wetlands. Va. Code § 62.1-44.3.
- 23. "Va. Code" means the Code of Virginia (1950), as amended.
- 24. "VAC" means the Virginia Administrative Code.
- 25. "VPDES" means Virginia Pollutant Discharge Elimination System.

SECTION C: Findings of Fact and Conclusions of Law

- 1. Henrico owns and operates the Facility in Henrico County, Virginia. The Facility's collection system serves Henrico residents and conveys sewage and municipal wastes to the Henrico County Water Reclamation Facility. The Permit allows Henrico to discharge treated sewage and other municipal wastes from the Facility, to the James River, in strict compliance with the terms and conditions of the Permit.
- 2. The James River is located in the Lower James River Basin. During the 2018 305(b)/303(d) Water Quality Assessment Integrated Report, the James River was considered a Category 5D waterbody ("The Water Quality Standard is not attained where Total Maximum Daily Loads (TMDLs) for a pollutant(s) have been developed but one or more pollutants are still causing impairment requiring additional TMDL development.") The stream is impaired of the Recreation Use due to E. coli exceedances. The Aquatic Life Use is impaired due to inadequate submerged aquatic vegetation (SAV), excess chlorophyll a, and an altered benthic community. The Fish Consumption Use is impaired due to a Virginia Department of Health (VDH) fish consumption advisory for PCBs and exceedances of the PCB water quality criteria; arsenic, mercury, and the VDH fish consumption advisory for kepone are considered non-impairing "observed effects". There was insufficient information to assess the Wildlife Use.

- 3. The Facility was included in the James River and Tributaries City of Richmond Bacterial TMDL (EPA approval November 4, 2010, Board approval June 29, 2012). The Facility received an E. coli wasteload allocation of 1.31e+14 cfu/year. The Chesapeake Bay TMDL was approved by the EPA on December 29, 2010. The TMDL allocates loads for total nitrogen, total phosphorus, and total suspended solids to protect the dissolved oxygen and submerged aquatic vegetation criteria in the Chesapeake Bay and its tidal tributaries. The Facility is considered a significant nutrient discharger and was included in the aggregated wasteload allocations for significant nutrient dischargers in the upper tidal freshwater James River estuary (JMSTF2.) The James River is considered a Tier 1 water.
- 4. The receiving streams influenced by Henrico's collection system overflows are the James River and the following tributaries: Almond Creek, Almond Creek UT, Chickahominy River UTs, Gillies Creek, Horse Swamp Creek, Hungary Creek, Lake Overton, North Run, North Run UT, Rooty Branch, Meredith Branch UT, Piney Branch UT, Upham Brook, and Upham Brook UT in the Lower James River Subbasin; as well as Tuckahoe Creek, Deep Run, Deep Run UT, Georges Branch, and the Kanawha Canal in the Middle James River Subbasin.
- 5. The James River and many of the tributaries were assessed as impaired during the 2018 305(b)/303(d) Integrated Water Quality Assessment. Several bacterial TMDLs have been adopted for the streams, including the Tuckahoe Creek, Upham Brook, James River (City of Richmond), and Chickahominy River watersheds. In addition, the Chickahominy River Benthic TMDL was completed in 2013.
- 6. On December 17, 2010, the Department issued a Consent Order to Henrico that contained a collection system project schedule that ran from December 15, 2010 to June 15, 2018, and Henrico completed all the listed projects in April of 2018.
- 7. On July 19, 2018, the DEQ's Piedmont Regional Office (PRO) was notified by Henrico Department of Public Utilities of an unpermitted discharge/sanitary sewer overflow located at 6705 Northbury Court, Henrico, Virginia. The initial report indicated the unpermitted discharge lasted for approximately 585 minutes, involved an estimated 144,495 gallons, and listed Almond Creek as the receiving stream. On July 20, 2018, the Department conducted a site inspection and observed evidence of long-term overflow of sewage at the location based on excessive bacterial growth on the stream bottom as well as the existence of aged sewage solids. Additionally, sewage odor was very prominent in the area and Almond Creek was turbid and gray. Evidence of sewage was observed approximately 3700 feet downstream of the manhole. DEQ staff interviewed a resident near Oakland Road who stated that sewage odors were observed approximately 2 months prior to inspection.
- 8. Henrico reported SSOs from the collection system from September 28, 2016 to August 16, 2021 as described in the table in Appendix A. Henrico asserts that a significant volume of SSOs are associated with extraordinary precipitation events.
- On September 18, 2018, the Department issued NOV No. W2018-09-P-0002 citing Henrico for 59 reported sanitary sewer overflows occurring from September 28, 2016 through August 18, 2018.

- 10. On November 1, 2018, the Department held an enforcement conference with Henrico to discuss the NOV. Henrico responded by submitting a plan and schedule of corrective action to address the unauthorized discharges from the sewer collection system.
- 11. On February 21, 2019, the Department issued NOV No. W2019-02-P-0002 to Henrico for 28 sanitary sewer overflows reported from September 17, 2018, through January 15, 2019.
- 12. On April 18, 2019, the Department issued NOV No. W2019-04-P-0001 to Henrico for 13 additional sanitary sewer overflows reported from January 17, 2019, through April 15, 2019.
- 13. On August 15, 2019, the Department issued an NOV No. W2019-08-P-0002 to Henrico for 5 additional sanitary sewer overflows reported from April 19, 2019, through July 8, 2019.
- 14. Henrico County reported to DEQ that beginning on February 6, 2020 at approximately 8 p.m. and ending on February 9, 2020 at approximately 6 a.m., the Facility experienced an intermittent loss of secondary and other solids. The loss of solids resulted in the following Outfall 001 Discharge Monitoring Report (DMR) data for the February 2020 monitoring period:

- 15. Between October 16, 2019 and March 29, 2020, Henrico County notified the Department that 164 "partial filter bypass events" occurred at the Facility.
- 16. On April 3, 2020, the Department issued NOV No. W2020-04-P-0001 to Henrico citing it for the effluent and bypass violations reported on the February 2020 DMR.
- 17. During the March and April 2020 monitoring periods, Henrico reported exceedances of Permit effluent limits for average and maximum concentration and average and maximum loading for both TSS and CBOD. In addition Henrico reported that 20 "partial filter bypass events" occurred during March 2020 and 70 had occurred during April 2020.

- 18. On June 3, 2020, the Department issued NOV No. W2020-06-P-0001 to Henrico citing it for the effluent and bypass violations reported on the March and April 2020 DMR.
- 19. During the May and June 2020 monitoring periods, Henrico reported exceedances of Permit effluent limits for average and maximum concentration and average and maximum loading for TSS. In addition Henrico reported that 31 "partial filter bypass events" occurred during May 2020 and 57 had occurred during June 2020.

- 20. On June 24, 2020, the Department held an enforcement conference on the phone to discuss the violations. During the meeting, Henrico stated that they have recognized the need for final filter rehabilitation at the treatment plant and have initiated both an interim and a long term corrective action plan.
- 21. On August 11, 2020, the Department issued NOV No. W2020-08-P-0001 to Henrico citing it for the effluent and bypass violations reported on the May and June 2020 DMR.
- 22. A review of DMRs submitted by Henrico since June 2020 indicates the Facility failed to meet Permit limits for TSS in August, November, and December of 2020, and February, and March of 2021. The Facility also failed to meet CBOD in August and December of 2020, and in February of 2021.
- 23. While acknowledging its responsibility to meet Permit effluent limits every month, Henrico asserts for environmental protection context only that: (a) the CBOD effluent limits in question were derived on the basis of a low flow critical condition and thus are overly-protective in the wet weather conditions when the alleged permit limit violations occurred; and (b) TSS levels in the James River are naturally elevated in wet weather conditions when the alleged permit limit violations occurred.
- 24. A review of DMRs submitted by Henrico since March 2021 indicates the Facility has met Permit effluent limits for CBOD in March of 2021 and for CBOD and TSS in March, April, May, June, and July of 2021.
- 25. Va. Code § 62.1-44.5 states that: "[E]xcept in compliance with a certificate issued by the Board, it shall be unlawful for any person to discharge into state waters sewage, industrial wastes, other wastes, or any noxious or deleterious substances."

- 26. Permit Part I.A.1 states "During the period beginning with the permit's effective date and lasting until the permit's expiration date, the permittee is authorized to discharge from outfall serial number 001. a. Such discharges shall be limited and monitored by the permittee as specified,,,,"
- 27. Permit Part II.U.3.a states "Bypass is prohibited, and the Board may take enforcement action against a permittee for bypass, unless: (1) Bypass was unavoidable to prevent loss of life, personal injury, or severe property damage; (2) There were no feasible alternatives to the bypass, such as the use of auxiliary treatment facilities, retention of untreated wastes, or maintenance during normal periods of equipment downtime. This condition is not satisfied if adequate back up equipment should have been installed in the exercise of reasonable engineering judgment to prevent a bypass which occurred during normal periods of equipment downtime or preventive maintenance; and (3) The permittee submitted notices as required under Part II.U.2.
- 28. The Regulation, at 9 VAC 25-31-50, also states that except in compliance with a VPDES permit, or another permit issued by the Board, it is unlawful to discharge into state waters sewage, industrial wastes or other wastes.
- 29. Va. Code § 62.1-44.15(5a) states that a VPDES permit is a "certificate" under the statute.
- 30. The Department has issued no permits or certificates to Henrico other than VPDES Permit No. VA0063690 for discharges from the Facility.
- 31. The James River, Almond Creek, Almond Creek UT, Chickahominy River UTs, Gillies Creek, Horse Swamp Creek, Hungary Creek, Lake Overton, North Run, North Run UT, Rooty Branch, Meredith Branch UT, Piney Branch UT, Upham Brook, and Upham Brook UT, Tuckahoe Creek, Deep Run, Deep Run UT, Georges Branch, and the Kanawha Canal are surface waters located wholly within the Commonwealth and are "state waters" under State Water Control Law.
- 32. Based on the Department's July 20, 2018 Almond Creek discharge investigation inspection, the November 1, 2018 meeting, and file review of the SSO reporting documentation Henrico submitted between September 2016 and July 2021, analysis of DMRs from October 2019 through July 2021, and the June 24, 2020 meeting, the Board concludes that Henrico has violated Va. Code 62.1-44.5, 9VAC 25-31-50, and Permit Parts I.A.1.a and II.U.3.
- 33. In order for Henrico to return to compliance, DEQ staff and representatives of Henrico have agreed to the following Schedules of Compliance, which are incorporated as: a) Appendix B: Henrico County SSO Repair and Maintenance Schedule & Statement of Work; b) Appendix C: Henrico County WRF Upgrade Schedule & Statement of Work; and c) Appendix D: Henrico County Supplemental Environmental Project of this Order. Henrico provided a project status report to DEQ on August 25, 2021 describing a series of projects completed between December 2019 and June 2021 to improve the sanitary sewer collection system, and to reduce SSO and infiltration/inflow (I&I)(Attachment 1).

SECTION D: Agreement and Order

Accordingly, by virtue of the authority granted it in Va. Code §§ 62.1-44.15, the Board orders Henrico, and Henrico agrees to:

- 1. Perform the actions described in Appendices B, C, and D of this Order; and
- 2. Pay a civil charge of \$207,680 in settlement of the violations cited in this Order, to be paid as follows:
 - a. Henrico shall pay \$51,920 of the civil charge within 30 days of the effective date of this Order. Payment shall be made by check, certified check, money order or cashier's check payable to the "Treasurer of Virginia," delivered to:

Receipts Control Department of Environmental Quality Post Office Box 1104 Richmond, Virginia 23218

Henrico shall include its Federal Employer Identification Number (FEIN) with the civil charge payment and shall indicate that the payment is being made in accordance with the requirements of this Order for deposit into the Virginia Environmental Emergency Response Fund VEERF.

- b. Henrico shall satisfy \$155,760 of the civil charge by satisfactorily completing the Supplemental Environmental Project (SEP) described in Appendix D of this Order.
- c. The net project costs of the SEP to Henrico shall not be less than the amount set forth in Paragraph D.2.b. If it is, Henrico shall pay the remaining amount in accordance with Paragraph D.2.a of this Order, unless otherwise agreed to by the Department. "Net project cost" means the net present after-tax cost of the SEP, including tax savings, grants, and first-year cost reductions and other efficiencies realized by virtue of project implementation. If the proposed SEP is for a project for which the party will receive an identifiable tax savings (e.g., tax credits for pollution control or recycling equipment), grants, or first-year operation cost reductions or other efficiencies, the net project cost shall be reduced by those amounts. The costs of those portions of SEPs that are funded by state or federal low-interest loans, contracts, or grants shall be deducted.
- d. By signing this Order, Henrico certifies that it has not commenced performance of the SEP.
- e. Henrico acknowledges that it is solely responsible for completing the SEP project. Any transfer of funds, tasks, or otherwise by Henrico to a third party, shall not relieve Henrico of its responsibility to complete the SEP as described in this Order.
- f. In the event it publicizes the SEP or the SEP results, Henrico shall state in a prominent manner that the project is part of a settlement of an enforcement action.
- g. The Department has the sole discretion to:
 - i. Authorize any alternate, equivalent SEP proposed by the Facility; and
 - ii. Determine whether the SEP, or alternate SEP, has been completed in a satisfactory manner.

- h. Should the Department determine that Henrico has not completed the SEP, or alternate SEP, in a satisfactory manner, the Department shall so notify Henrico in writing. Within 30 days of being notified, Henrico shall pay the amount specified in Paragraph D.2.b, above, as provided in Paragraph D.2.a, above.
- i. If the Department has to refer collection of moneys due under this Order to the Department of Law, Henrico shall be liable for attorneys' fees of 30% of the amount outstanding

SECTION E: Administrative Provisions

- 1. The Board may modify, rewrite, or amend this Order with the consent of Henrico for good cause shown by Henrico, or on its own motion pursuant to the Administrative Process Act, Va. Code § 2.2-4000 *et seq.*, after notice and opportunity to be heard.
- 2. This Order addresses and resolves only those violations specifically identified in Section C of this Order. This Order does not otherwise preclude the Board or the Director from taking any action authorized by law, including but not limited to: (1) taking any action authorized by law regarding any additional, subsequent, or subsequently discovered violations; (2) seeking subsequent remediation of the Facility; or (3) taking subsequent action to enforce the Order
- 3. For purposes of this Order and subsequent actions with respect to this Order only, Henrico admits the jurisdictional allegations, and agrees not to contest, but neither admits or denies, findings of fact, and conclusions of law contained herein.
- 4. Henrico consents to venue in the Circuit Court of the City of Richmond for any civil action taken to enforce the terms of this Order.
- 5. Henrico declares it has received fair and due process under the Administrative Process Act and the State Water Control Law and it waives the right to any hearing or other administrative proceeding authorized or required by law or regulation, and to any judicial review of any issue of fact or law contained herein. Nothing herein shall be construed as a waiver of the right to any administrative proceeding for, or to judicial review of, any action taken by the Board to modify, rewrite, amend, or enforce this Order.
- 6. Failure by Henrico to comply with any of the terms of this Order shall constitute a violation of an order of the Board. Nothing herein shall waive the initiation of appropriate enforcement actions or the issuance of additional orders as appropriate by the Board or the Director as a result of such violations. Nothing herein shall affect appropriate enforcement actions by any other federal, state, or local regulatory authority.
- 7. If any provision of this Order is found to be unenforceable for any reason, the remainder of the Order shall remain in full force and effect.
- 8. Henrico shall be responsible for failure to comply with any of the terms and conditions of this Order unless compliance is made impossible by earthquake, flood, other acts of God, war, strike, or such other unforeseeable circumstances beyond its control and not due to a lack of good faith or diligence on its part. Henrico shall demonstrate that such circumstances were beyond its

control and not due to a lack of good faith or diligence on its part. Henrico shall notify the DEQ Regional Director verbally within 24 hours and in writing within three business days when circumstances are anticipated to occur, are occurring, or have occurred that may delay compliance or cause noncompliance with any requirement of the Order. Such notice shall set forth:

- a. the reasons for the delay or noncompliance;
- b. the projected duration of any such delay or noncompliance;
- c. the measures taken and to be taken to prevent or minimize such delay or noncompliance; and
- d. the timetable by which such measures will be implemented and the date full compliance will be achieved.

Failure to so notify the Regional Director verbally within 24 hours and in writing within three business days, of learning of any condition above, which the parties intend to assert will result in the impossibility of compliance, shall constitute a waiver of any claim to inability to comply with a requirement of this Order.

- 9. This Order is binding on the parties hereto, and any successors in interest, designees and assigns, jointly and severally.
- 10. This Order shall become effective upon execution by both the Director or his designee and Henrico. Nevertheless, Henrico agrees to be bound by any compliance date which precedes the effective date of this Order.
- 11. This Order shall continue in effect until:
 - a. The Director or his designee terminates the Order after Henrico has completed all of the requirements of the Order;
 - b. Henrico petitions the Director or his designee to terminate the Order after it has completed all of the requirements of the Order and the Director or his designee approves the termination of the Order; or
 - c. the Director or Board terminates the Order in his or its sole discretion upon 30 days' written notice to Henrico.

Termination of this Order, or any obligation imposed in this Order, shall not operate to relieve Henrico from its obligation to comply with any statute, regulation, permit condition, other order, certificate, certification, standard, or requirement otherwise applicable.

12. Any plans, reports, schedules or specifications attached hereto or submitted by Henrico and approved by the Department pursuant to this Order are incorporated into this Order. Any non-compliance with such approved documents shall be considered a violation of this Order.

- 13. The undersigned representative of Henrico certifies that he or she is a responsible official authorized to enter into the terms and conditions of this Order and to execute and legally bind Henrico to this document. Henrico shall respond to any Department questions or concerns within ten days of receipt. The CAP must include, at a minimum, the following projects under design:
 - a) Clarifier Replacement Project: Phase I Rehabilitation of 3 primary clarifiers;
 - b) Boiler Burner Replacement: Replace 3 burners with dual fuel capability;
 - c) Clarifier Replacement Project: Phase II Rehabilitation of 3 primary clarifiers;
 - d) Asset Management Program: Complete Computerized Maintenance Management System ("CMMS"), WRF Equipment Replacement Plan, and Capital Improvement Program (CIP) Implementation Plan;
 - e) Return Activated Sludge ("RAS") Pump Replacement: Replace and/or refurbish up to 9 vertical turbine pumps, Variable Frequency Drives ("VFDs"), and control systems;
 - f) Water Reclamation Facility Supervisory Control and Data Acquisition ("SCADA") Replacement Project: Replace the existing Human Machine Interface ("HMI"), Programmable Logic Controls ("PLCs") and SCADA software;
 - g) Plant Main Drain Sewage Pumping Station Renewal (Wet Well, Pumps, Controls, Switchgear): Remove existing vertical turbine pumps and replace with triplex submersible pump system to include wet well expansion and control system;
 - h) Filter Project (Phase I) Renew filters.
 - i) Clarifier Replacement Project, Phase III Rehabilitation of 6 secondary clarifiers
 - j) Clarifier Replacement Project, Phase IV Rehabilitation of 5 secondary clarifiers
- 2. Begin implementation of the CAP within ten days after receiving notification of the Department's approval.
- 3. Within 60 (sixty) days of the Department's CAP approval, begin public bid process on the construction phase of the CAP.
- 4. On or before December 15, 2028, complete the CAP deliverables.

APPENDIX D

HENRICO COUNTY SUPPLEMENTAL ENVIRONMENTAL PROJECT

- 1. This Supplemental Environmental Project (SEP) for Public Health, Pollution Prevention, Pollution Reduction, Environmental Restoration and Protection, and Environmental Compliance Promotion is for expanding Henrico County's public wastewater infrastructure to un-served properties, and take off-line private septic systems discharging on-site, and convey collected wastewater to the Facility for advanced treatment including nitrogen and phosphorus removal. Henrico shall expend \$155,760 on this septic system replacement effort to satisfy Section D.2.b. of this Order.
- 2. The SEP shall be planned and implemented by October 1, 2024.
- 3. Henrico shall submit progress reports on the SEP on a monthly basis, due the 10th day of each month.
- 4. Henrico shall submit a written final report on the SEP, verifying that the SEP has been completed in accordance with the terms of this Order, and certified either by a Certified Public Accountant or by a responsible public utility officer. Henrico shall submit the final report and certification to the Department within 30 days from the completion of the SEP.
- 5. If the SEP has not or cannot be completed as described in the Order, Henrico shall notify DEQ in writing no later than 15 days after discovery. Such notification shall include:
 a. an alternate SEP proposal, or
 b. payment of the amount specified in Paragraph D.2 as described in Paragraph D.1.
- 6. Henrico hereby consents to reasonable access by DEQ or its staff to property or documents under the party's control, for verifying progress or completion of the SEP.
- 7. Henrico shall submit to the Department written verification of the final overall and net project cost of the SEP in the form of a certified statement itemizing costs, invoices and proof of payment, or similar documentation within 30 days of the project completion date. For the purposes of this submittal, net project costs can be either the actual, final net project costs or the projected net project costs if such projected net project costs statement is accompanied by a CPA certification or certification from Henrico's Chief Financial Officer concerning the projected tax savings, grants or first-year operation cost reductions or other efficiencies.
- 8. Documents to be submitted to the Department, other than the civil charge payment described in Section D of the Order, shall be sent to:
